Donation Regulation

According to the statutes of the association Ka mag-anak all money, which exceeds the requirement of the club, has to be donated. There are two forms of donations

- a) Donations organized by the members of Ka mag-anak. Following the rules of the statutes all member will have the right to use some of the money of Ka mag-anak for donations
- b) Donations because of special events.

The sequence of the members responsible for the next donation is defined like follows:

There is a bonus system, which will be evaluated every year as part of the main meeting of the club. The base of the evaluation is the 31st of December of the preceding year. Every member has an own account of the bonus points; the points earned within a family will be accumulated at the end. Bonus points cannot be transferred. The member or family with the highest value has the right to organize a donation on behalf of the club. When there is more than one member with the identical amount of bonus points, the number of years as a member will decide who is next. If this is still equal, the dice will decide. After the donation has been assigned the bonus points will be deleted for that member/family. When a member does not want to use the right for the next donation, the right will proceed to the member with the next higher bonus account. The account of the forwarding member will not be deleted, so that he has very good chances that he will be able to arrange his donation in the next year.

The secretary will maintain the bonus accounts.

The amount, which is available for a donation, is 500€. This amount can be increased in special cases by the board of the club. Furthermore special donations dedicated for this purpose can be made to increase this amount as well. When the club has succeeded to earn more money in a given year, further donations can be done, organized by the members with the next highest bonus account. The number of donations will be fixed in the yearly main meeting of the club.

The bonus system:

- a) Per Year of membership 50 bonus points
- b) Participants on the main yearly meeting will receive 10 bonus points
- c) Per active participation on an external event (f.i. dance presentation) 25 bonus points
- d) Per extra training Session 5 bonus points
- e) Per active work for a club event 50 bonus points.
- f) Main position in the club per 5 Year 150 bonus points
- g) Side position in the club per 5 year 75 bonus points
- h) Sporadic activity (controlling of the bookkeeping) 25 bonus points

Kids can only earn bonus points when they actively participate in an event and in training sessions. Helping to organize some events for the club will be honored with 25 bonus points.

The total sum of the yearly membership fees of all members should not be used for donations.

The club has the right to check the donations. In case that the donation money has been misused the amount has to be transferred back to the club and member will be excluded form the club.

Explanations: Donations because of special events.

It can always happen that the club will help, especially with donations. Such cases are:

- i) Special events**
- j) Emergency situation for Filipinas**

Explanation: Bonus system

Ad a: The number of years of the membership is an essential part of the bonus system. Once a donation has been done, that number will be zeroed.

Ad b: Active participation in the activities of the club will be honored. All activity where the club can profit from will be honored.

Ad c: Participation on the yearly main meeting is important. Therefore you can receive bonus points here.

Ad d: Presentation as part of internal or external events (dancing/singing/other performances) will be honored, This applies as well the helping people in the background (for instance the driver)

Ad e: Of course it is required to do training sessions. Participation here will be honored as well, even when there is no subsequent public presentation. Training session as part of a normal meeting will not be honored, with the exception of training for the kids.

Ad f: Preparation and cleanup for events organized by the club cost a lot of time, but save a lot of money, which then can be used for donations. Therefore such activities will be honored with bonus points as well. Multiple day activities will be honored on a daily bases..

Ad g: Main Positions in the club are:

- 1. The chairman / woman**
- 2. The treasurer**
- 3. Trainer (Per 5 years)**
- 4. Secretary (Per 5 years)**
- 5. Webmaster (Per 5 years)**
- 6. Regional leader**

Ad h) Side positions in the club are:

- 1. Second chairman / woman**
- 2. Co-trainer (Per 5 years)**

Bonus points, Which are earned because of a position in the club will be divided by the number of years of the respective term (by 5), and will be accumulated yearly.

Ad f: Single activities, like checking the bookkeeping, will be honored as well. Other examples are to rework the statutes, or any other activity, which is not mentioned in the rules above. The directors of the club wil decide whether an activity can be honored or not. So, be creative, it is worth it.

Explanation for the family evaluation:

The reason that the bonus points of families are added up at the end of the bonus evaluation is, that not two member of a family can do a donation in the same year. This is not an advantage compared with single members. Lets explain: Lets assume that there are only single accounts, and based on these every ten years a member will get the right for a donation. This means that the two partner in a family will have to do 2 donations in each ten years. When the accounts will be added up at the end this simply means that the donation can be done every 5 years (equals 2 per 10 years), but there will be no two donations at the same time. Remember, these number are hypothetical number and are only used to explain the rules.
